

**Jose Lake Improvement Association  
Meeting Minutes 2006**

The meeting of the Jose Lake Improvement Association was called to order at 10:05 a. m., on July 1, 2006, by President, Chuck Lauria. The Board of Directors was introduced, and new members were welcomed.

The minutes of the last meeting were read. Ed Wlodarczyk moved to accept the minutes as read. Frank Purczynski seconded the motion, and the motion passed.

Donald Rem moved to accept the report as read. Tom Fox seconded and the motion was passed.

Joe Moran reported on our fish program. Four hundred fifty walleye and 450 crappie were planted in the lake last fall. We ordered 4-6 inch walleye. Three to five inch fish were delivered. The price was adjusted accordingly. Skip reported that the blue gill fishing has been good. Ed Wlodarczyk moved to continue our fish program spending about \$1000 on fish. Donald Rem seconded the motion. Some members were concerned that there are too many blue gill. Discussion followed with the opinion being that the hybrids are fun to catch and don't produce rapidly. The motion was passed to continue of fish stocking program.

Ralph Kull moved to keep our donation to the fire department at \$300, the donation to the Hale Citizens' Patrol at \$200, and the secretary's salary at \$300. Ed Wlodarczyk seconded and the motion carried.

The forest cleanup was held on May 20, 2006. Seventeen people participated. These hard workers cleared 32 sites and filled a 30 yard dumpster, some trailers, and a truck. The Proctors at the store provided food and refreshments for the workers. Thanks to all for a job well done. Look for details for the next clean-up. There have been a lot of leaves being dumped illegally. All leaves should be taken to the dump. Tickets will be issued for dumping leaves and debris illegally.

**Skip and George Brown were up for reelection. Chuck asked for nominations for directors. Ed Wlodarczyk moved to elect Skip and George by acclamation. The motion was seconded and passed.**

**A discussion took place about increasing membership. It was suggested that each member invite one family to join the Association.**

**Tom Fox brought up an incident that happened on the lake. Some people were behaving inappropriately, and unfortunately, it was in front of young children. Report any incidents to the Marine division. The number is 989 362-6174 or dial 911. We want to keep our lake a fun and safe place to be for all of us.**

**We asked for judges for the July 4 parade. Chuck Lauria, Jo King, C. J. Schuman, and Ray Hollenback volunteered.**

**Chuck Parkinson spoke to the membership. He informed us of some of the new rules for Off-road Vehicles. They are allowed on the road at 20 mph. None are allowed after dark. If violations occur call central dispatch.**

**Pete Tate volunteered to take any dues that people wish to pay. We discussed placing a donation box either at the store or the boat launch. We will look into the pros and cons of this idea.**

**Ralph Kull moved to adjourn the meeting. Donald Rem seconded. The meeting was adjourned.**
